## Crowndale Road area Safe and Healthy Streets – additional measures (Oakley Square)

The Camden (Parking Places) (CA-F) (Amendment No. \*\*) Traffic Order 202\*

- Notice is hereby given that the Council of the London Borough of Camden ('the Council') propose to make the above Order under section 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
- 2. The general nature and effect of the Order would be:-
  - (a) in OAKLEY SQUARE (north-west arm), to remove 10 metres of paid-for parking space and replace it with a shared-use (CA-F resident permit holders and paid-for) parking place on the south-east side, between 26 and 36 metres north-east of the common boundary of Nos. 51 and 53 Oakley Square; and
  - (b) to provide that the hours during which the shared-use parking place referred to in sub-paragraph (a) preceding would operate would be: (1) for CA-F permit holders - Mondays to Fridays 8.30am to 6.30pm and Saturdays & Sundays 9.30am to 5.30pm; and (2) for paid-for parking: Mondays to Fridays 8.30am to 6.30pm and Saturdays 9.30am to 5.30pm. Paid-for parking would have a maximum stay of 2 hours and the charges would be as follows:
    - Electric vehicles £4.83 per hour; Euro 6 compliant petrol vehicles and Euro 6d/6d-TEMP compliant diesel vehicles: CO2 emissions up to 120g/km £5.80 per hour, over 121g/km £7.53 per hour. Air quality surcharge for non-compliant vehicles: petrol vehicles CO2 emissions up to 120g/km £1.45, over 121g/km £1.88; diesel vehicles CO2 emissions up to 120g/km £2.90, over 121g/km £3.77.

### Statement of reasons

## Crowndale Road area Safe and Healthy Streets – additional measures (Oakley Square)

The Camden (Parking Places) (CA-F) (Amendment No. \*\*) Traffic Order 202\*

The reasons for proposing to convert two paid for parking bays on Oakley Square (north) to shared paid for and permit holder bays to support the introduction of the Crowndale Road Safe and Healthy Streets scheme as set out in detail within the decision report for the scheme. In summary the reasons are to:

- Recognise residents' concerns that demand for residents' bays would
  potentially increase if resident permit bays on Oakley Square are removed to
  create two disabled bays as part of the Crowndale Road Safe and Healthy
  Streets scheme. The proposed solutions are considered proportionate to
  address the concerns raised without delaying the implementation of the Safe
  and Healthy Streets proposals.
- Recognise that there is likely to be continued need for the paid for parking bays on Oakley Square (north) as a result of the removal of existing single yellow lines on Crowndale Road, to facilitate the introduction of cycle lanes on this road.
- resilience measures including new tree planting and rain gardens. Making the
  area a nicer place to meet, stop, rest, and shop by planting new plants and
  trees, adding new benches and reducing street clutter. Respond to the positive
  consultation response on the scheme proposals. This aligns with the fact that
  70% of respondents of the public consultation supported the proposals and
  wanted to see these implemented.
- Deliver the recommendation made by the Citizens' Assembly on the Climate Crisis to introduce more segregated cycle lanes in the borough, and more urban greenery, and accompanying actions within the Climate Action Plan.
- Contribute to delivering key London-wide and Borough-wide strategies, such as the Mayor's Transport Strategy, Camden's Transport Strategy, the Clean Air Action Plan and the Climate Action Plan. Deliver the objectives of the Somers Town Future Neighbourhoods 2030 programme and contribute to making Somers Town a healthier, more sustainable and climate resilient place. Deliver the commitment the Council has made to organisations providing funding for the implementation of this scheme, such as the Greater London Authority (GLA) and Transport for London (TfL).
- The Crowndale Road Area Safe and Healthy Streets Proposals are suggested based on the alignment with Council and Mayoral policy, the positive response to the public consultation, the monitoring data and other feedback received as part of engagement conducted during the development of the scheme.

The Council of the London Borough of Camden, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984<sup>1</sup>, and of all other powers thereunto enabling, hereby make the following Order:

#### Citation and commencement

1.1 This Order may be cited as the Camden (Parking Places) (CA-F) (Amendment No. \*\*) Traffic Order 202\* and shall come into force on \*\* \*\*\*\*\*\* 202\*.

#### Interpretation

2.1 In this Order:

"enactment" means any enactment, whether public general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment; and

- "the Order of 2012" means the Camden (Parking Places) (CA-F) Traffic Order 2012<sup>2</sup>, as amended.
- 2.2 Any reference in this Order to any other Order or enactment shall be construed as a reference to that Order or enactment as amended, applied, consolidated, reenacted by, or as having effect by virtue of any subsequent Order or enactment.
- 2.3 Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2012 shall have the same meaning as in that Order.

#### Revocation and designation of parking places

- 3.1 Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into force of this Order the Order of 2012 shall have effect as though:
  - (a) any parking place in Schedule 2 to that Order that is situated on the southeast side of Oakley Square (north-west arm), extending for approximately 36 metres north-east of the common boundary of Nos. 51 and 52 Oakley Square, were revoked;
  - (b) there were added to Schedule 2 to that Order, the item set out in Schedule 1 to this Order; and
  - (c) there were added to Schedule 3 to that Order, the item set out in Schedule 2 to this Order.
