Green Badge application and renewal – essential information

Who can apply?

To qualify for a Green Badge you must hold a Blue Badge and either:

- live in Camden in the Green Badge area,
- work in Camden (full or part-time) in the Green Badge area;
- study in Camden (full or part-time) in the Green Badge area.

Proof of resident work or study

The Council has access to system which can verify your residency. If you are applying under the work or study criteria, you will need to provide the proof as listed below:

Proof of work or study

- a letter from your employer on a company letter headed paper, signed by an official confirming your place of employment and the number of hours, days, months that you work in the Green Badge area.
- a letter from your college or university on a letter headed paper, signed by an official confirming your place of study and the number of hours, days, months that you study in the Green Badge area.

Can I complete the form on behalf of the applicant?

When we ask for a signature this should be of the applicant's except where the applicant is under the age of 16, in which case the parent or carer should sign; or where the applicant's disability prevents them writing, in this case a letter confirming Power of Attorney must be provided showing the authorised signatory who should sign.

Where can I park?

The Green Badge scheme runs in conjunction with the blue badge scheme and operates throughout part of the Camden borough where acute traffic and parking pressures mean fewer parking spaces are available than in other areas.

Those who hold **both** a Green and Blue Badge can park in:

- Blue Badge bays,
- shared use loading bays,
- shared use disabled bays,
- residents' bays; and
- paid for parking bays.

Green Badge holders may also be eligible for temporary hospital dispensations which allow you to park on yellow lines near hospitals within the Green Badge area. To be eligible you must hold both a Blue and Green Badge and you will need to provide a hospital appointment letter, a copy of your Blue Badge and vehicle registration documentation (V5C or log book). For more information please be advised by the Hospital.

How do I apply?

Complete the form overleaf and return to Concessionary Travel along with the required proofs by email – cats@camden.gov.uk or post to Concessionary Travel PO BOX 64175 London WC1A 9BY. The Green Badge is valid for 3 years for residents within the zone and 1 year for workers and students. After this time permit holders will need to reapply, completing the form and providing updated proofs.

Vehicles

You can nominate up to three vehicles in which the Green Badge can be used in. You can use your green badge in anyone vehicle at a time, and only on the days that you indicated on your green badge application form.

Where do I display my permit?

You must display your Green Badge in your front vehicle windscreen with the barcode facing upwards. Failure to do so may result in a parking ticket being issued or your vehicle being removed.

When do I need to display both my blue and green badges?

If you wish to park in a resident's, metered or pay-and-display bay both your Blue and Green Badges should be clearly displayed on the dashboard of your vehicle. If you wish to park in a Blue Badge bay then you will only require your Blue Badge. Please ensure that the expiry date and issuing authority are visible on your Blue Badge.

Lost or stolen permits

If your Green Badge is lost or stolen you must report it to the police. You will need to contact Concessionary Travel Department via the contact information below.

There will be a fee of £10 for replacing stolen or lost Green Badges.

Data protection

No personal information you provide us will be passed on for commercial purposes. Our policy is that information will only be shared among officers and other agencies where the legal framework allows it, and where it will help to improve the service you receive and to develop other services.

Warning

It is your responsibility to ensure that your green badge is properly used. You must not lend it to anyone else and misuse could result in your badge being withdrawn. It is a criminal offence for able bodied people to use your badge, and if they do so they are liable for a fine of up to £1,000.

It is also a criminal offence to make a false statement for the purpose of obtaining any permit, and upon summary conviction is subject to a fine of up to £2,500. It is a criminal offence to allow the misuse of the permit which the offender is liable (a) on conviction on indictment to imprisonment for a term not exceeding 2 years (b) on summary conviction is subject to a fine of up to £5,000.
